Authorization to Contract for Fire Alarm Inspections

BACKGROUND

The San Diego Convention Center has a significant fire life safety infrastructure that requires periodic inspections, testing, and maintenance. Due to the specialized nature, Staff has historically selected an outside contractor to ensure compliance with National Fire Protection Association (NFPA) standards, insurance requirements, and all applicable codes and regulations. These are anticipated requirements that Staff budgets for annually.

DISCUSSION

Staff issued a request for proposals with an itemized list of sixteen (16) services needed from qualified contractors to conduct fire safety inspections, testing, and maintenance. Staff received three (3) proposals with each bidder submitting for the requirements their company is capable of and interested in performing. Staff evaluated the proposals and recommends awarding multiple contracts with a three (3) year initial term and two (2) single year options to extend at a cost of:

Staff is recommending award of a contract to Sygnal Systems for six (6) of the required services with a 3-year commitment of \$327,944.49 (\$563,299.31 with both extension options).

Staff is recommending award of a contract to Johnson Controls for six (6) of the required services with a 3-year commitment of \$188,661.36 (\$330,681.40 with both extension options).

STAFF RECOMMENDATION

Approve authorization to contract with Sygnal Systems and Johnson Controls.
